PUBLIC HEALTH ADVOCATES



Empower patients by helping them get access to affordable, effective, high-quality healthcare. They work one on one with patient concerns in healthcare or social service settings. Typical responsibilities can include:

- Providing support navigating the health insurance process.
 This can include explaining coverage, filing claims, and explaining billing.
- Assist patients in navigating the clinical environment to better work with healthcare providers in diverse environments.
- Provide guidance for a patient to make informed choices about their health care condition and treatment options

POLICY MAKING PROCESS

How Federal Laws Are Made

Congress is the legislative branch of the federal government and makes laws for the nation.

Congress has two legislative bodies or chambers: the U.S. Senate and the U.S. House of Representatives.

Anyone elected to either body can propose a new law. A bill is a proposal for a new law.



POLICY MAKING PROCESS

"ENSURING CLEAN DRINKING WATER IN THE LOS ANGELES UNIFIED SCHOOL DISTRICT"



Students at Roosevelt High School have limited access to water on campus and refuse to drink water from the nearby water fountains because they believe it is unsafe to consume due to potential lead contamination.


Additionally, an ongoing school renovation project further limits access to water because students must walk long distances to reach their classrooms and have limited opportunities to find water fountains to rehydrate.

+ HEALTH ISSUE +

Testing of the water in drinking fountains at schools revealed high levels of lead.

Lead is known to damage the brain and nervous system. it can cause learning and developmental delays and affect growth, hearing, and speech. kids are very susceptible to lead poisining.





ACTION



Community Mobilization

Students gathered hundreds of signatures and rallied students to testify at school board meetings.





In April 2019, LAUSD allocated \$15 million to test water quality and upgrade drinking fountains throughout the district!

This money went to fund:

- Sampling all active drinking water fountains at all school sites
- Upgrading drinking water fountains to bring lead levels to below five parts per billion (pbb)
- Installing water bottle filling stations at selected school sites

COMMUNICATING TO LAWMAKERS

Keep it Brief & Focused

- Do not exceed 1 page
- Focus on only 1 issue
- Introduce yourself and why you are writing (refer to a bill # if relevant)

Be Persuasive

- Provide 3 strong points to support your topic
- Personalize it with your relevant story of how it affects you & your family

Respectfully Ask

- Be clear and firm in what you want your lawmaker to do.
- Be respectful and offer to be a resource for future contact.
